- A completed application form needs to be filed and approved by the Village Board at the June meeting or prior to the June meeting; along with a letter of intent that the liability insurance and State Fire Marshal license will be submitted prior to the selling of Fireworks;
- 3. A \$75.00 permit fee for each retail sales location or commercial display permit must accompany the application form for July 1-4; Checks made payable to the Village of Malcolm;
- 4. A \$25.00 permit fee for retail sales location for December 28 31; Checks made payable to the Village of Malcolm;
- 5. A copy of the applicant's liability insurance in the amount of \$1,000,000.00 for Bodily Injury and \$1,000,000.00 for Property Damage must be provided to the Village Office prior to the selling of fireworks;
- 6. A copy of the State Fire Marshall License must be provided to the Village Office and; the original MUST be displayed at the stand prior to the selling of fireworks

Permissible fireworks may be sold at retail, offered for sale at retail from:

July 1 through July 3 from 9:30 a.m. – 10:30 p.m.

July 4 from 9:30 a.m. – 12:30 a.m. on July 5

December 28 – December 30 from 9:30 a.m. - 10:30 p.m.

December 31 from 9:30 a.m. – 12:00 midnight
