FIREWORKS REQUIREMENTS

1. Said applicant agrees to hold harmless the Village of Malcolm from any and all liability from the operations of fireworks business and sale of fireworks except that arising out of the sole negligence of the Village of Malcolm.
2. A completed application form needs to be filed and approved by the Village Board at the June meeting or prior to the June meeting; along with a letter of intent that the liability insurance and State Fire Marshal license will be submitted prior to the selling of Fireworks;
3. A \$75.00 permit fee for each retail sales location or commercial display permit must accompany the application form for July 1-4; Checks made payable to the Village of Malcolm;
4. A \$25.00 permit fee for retail sales location for December 28 – 31; Checks made payable to the Village of Malcolm;
5. A copy of the applicant's liability insurance in the amount of \$1,000,000.00 for Bodily Injury and \$1,000,000.00 for Property Damage must be provided to the Village Office prior to the selling of fireworks;
6. A copy of the State Fire Marshall License must be provided to the Village Office and; the original MUST be displayed at the stand prior to the selling of fireworks

Permissible fireworks may be sold at retail, offered for sale at retail from:

July 1 through July 3 from 9:30 a.m. – 10:30 p.m.

July 4 from 9:30 a.m. – 12:30 a.m. on July 5

December 28 – December 30 from 9:30 a.m. - 10:30 p.m.

December 31 from 9:30 a.m. – 12:00 midnight

I hereby certify that the data submitted on or with this Application is true and correct, that I am the Owner/Applicant at this address, or that for the purpose of obtaining this Sales/Commercial Displays of Fireworks Permit, I am acting as the agent on the Owner’s behalf, with full authority to do so. When approved this Application becomes a Permit to sell or display fireworks, as applicable. Granting of this permit does not presume to give authority to violate or cancel the provisions of any state or local law.
